

Challenge

Title Examiner Capacity Ceiling and the Cost of Expertise

The in-house title exam and curative process was a major bottleneck for Hofmann's team. The manual, document-by-document review required hours of work from AEGIS Land Title Group's most expensive and talented examiners, limiting production to approximately 10 commitments per title examiner per day. This capacity constraint meant that business growth required the costly and difficult process of hiring and training new experts.

By offloading the repetitive document work, examiners are empowered to move through files twice as fast, effectively **doubling production capacity from 10 to 20 commitments per day per title examiner.**

"If my people can just drag search packages into Qualia Clear and the system automates that task, all of a sudden, title examiners can do 20 commitments a day. That gives me an awful lot of elasticity as volumes change. That was a huge 'aha moment' for me," said Hofmann.
